MEMBERSHIP FREQUENTLY ASKED QUESTIONS

Q: Last year I paid \$185.00 for CAADAC and NAADAC full membership, will this price decrease any time soon?

A: As of July 1, 2008 CAADAC is no longer associated with NAADAC so all new and renewals of full CAADAC membership will only be \$100.00 annually.

Q: I am a registrant, do I need to be a member?

A: Membership is not required, but is strongly encouraged. Full CAADAC members receive large discounts on their certification process as well as many other discounts. (see website for all of the full membership benefits at www.caadac.org.)

Registrant Status is separate from membership and is billed as such.

Q: I am already fully certified, do I need to be a member?

A: Membership is not required, but is strongly encouraged. Full CAADAC members receive large discounts on their certification as well as many other discounts. (see website for all of the full membership benefits at www.caadac.org.)

Certification is separate from membership and is billed as such.

Q: What are the requirements for the Retired Membership category?

A: Retired individuals must be fully retired (not working in the Alcohol/Drug Profession) and be 65 years or older.

Q: What are the benefits for the Retired Member?

A: The Retired category includes all of the membership benefits that the full CAADAC members receive with the exception of voting privileges and certification discounts. This category was implemented for those who would like to receive the full CAADAC membership benefits such as discounted liability insurance and health/dental/auto/home insurance, but have no desire for being involved in the election process or need for certification discounts.
