MEMBERSHIP FREQUENTLY ASKED QUESTIONS

Q: Last year, I paid \$185.00 for CAADAC and NAADAC full membership; will this price decrease any time soon?

A: Effective July 1, 2008 all new and renewal full members will only pay \$100 for full CAADAC membership. The CAADAC Board of Directors reduced membership dues by \$25.00 for your benefit! NAADAC is no longer affiliated with CAADAC.

Q: What are the requirements for the Retired Membership category?

A: Retired individuals must be fully retired (not working in the Alcohol/Drug Profession) and be 65 years or older.

Q: What are the benefits for the Retired Member?

A: The Retired category includes all membership benefits that the full members receive with exception to certification discounts and voting privileges. This category was implemented for those who would like to receive the CAADAC benefits such as discounted liability insurance and health/dental/auto/home insurance but have no need or desire for certification discounts and does not choose to be involved in the election process.

Q: I am already fully certified, do I need to be a member?

A: Membership is not required but is strongly encouraged. Full CAADAC membership give large discounts on your certification renewal as well as many other discounts. (see website for all of the membership benefits caadac.org).
